By signing this Waiver of Claims, Release of Liability, Acknowledgement and Assumption of Risks Agreement, YOU give up the right to SUE for ANY and all; Injuries, bodily, mentally, virally or monetary or property damages, howsoever caused.

The individual Releasor engaging in any and all activities is defined as; a participant, guest, volunteer, spectator and/or parent/guardian who is completing this waiver and release on behalf of themselves, a spouse or child/ward.

3. Waiver and Release

I hereby waive, release and forever discharge the following:

- (a) I agree to indemnify and hold harmless the Releasee, their officers, employees, agents, volunteers and representatives from any and all claims, damages, losses, injuries and expenses arising out of or resulting from participating in these activities. I further agree to release, acquit and covenant not to sue Releasee, their agents and employees for any and all actions of Releasee.
- (b) I agree to waive any and all claims I may have against the Releasee, and release from all liability and agree not to sue Releasee and it's officers, employees, agents, volunteers and representatives, for any personally injury, death, property damage or loss sustained as a result of myself, my spouse or son or daughter's participation in the outdoor activity arising out of any cause whatsoever, including negligence.

4. Parent or Guardian

If I am the parent or guardian of the participant, I have completed the Agreement as the "Releasor" as required above, I have read and understand and execute this Waiver and Release (Agreement) on behalf of my spouse or child/ward. In the event, for any reason, it is determined that my execution of this Agreement is determined not to be effective to impose the terms of this release, I agree to indemnify the corporation (Releasee) with respects to all claims advanced by or on behalf of my spouse or child/ward. I am accepting the risk of an accident occurring, and agree that this activity, is suitable for my spouse and son or daughter.

5. Agreement to Terms

- (a) I acknowledge that the "Activities" involve inherent risks and dangers that may cause serious injury and possible death. I fully understand the risks and dangers associated with the "Activities" and accept same entirely at my own risk.
- (b) I understand that this document, as outlined above, contains a promise not to sue the Releasee or any of it's members and that it constitutes a release of Liability and an indemnity for all claims.
- (c) I fully comprehend and understand the implications of this Agreement and I am aware of the risks and accept them.
- (d) Wildwood Sailing Club (WSC) has put in place preventative measures to reduce the spread of COVID-19; however, WSC cannot guarantee that you, your spouse or your child(ren) will not become infected with COVID-19. Further, attending WSC and it's events could increase your risk and your spouse or child(ren)'s risk of contracting COVID-19.
- (e) I am signing this document freely and voluntarily and I accept that printing/typing my name in this document is my signature for these purposes.

In signing this waiver, I am not relying on any oral or written representation or statements made by the Releasee, its officers, employees, agents, volunteers and representatives to induce me, my spouse and/or my child to participate other than those set out in this Waiver. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren), spouse or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I, my spouse or my child(ren) may experience or incur in connection with myself, my spouse or child(ren)'s attendance at the WSC and its events ("Claims"). On my behalf, and on behalf of my spouse or child(ren), I hereby release, covenant not to sue, discharge, and hold harmless the WSC, its employees, officers, directors, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.
